SCHOOL FEES

The fees are currently payable as follows:

Registration Fee: £50.00 (non-refundable).

Deposit: On acceptance of a place at the School a deposit of £300 is payable.

- (i) This deposit is repaid when the child leaves the School, after deducting any amounts then outstanding.
- (ii) The sum is forfeit in the event of subsequent withdrawal before actually joining the School.

Individual Music Tuition: The fees are payable direct to the Music Academy.

Fees include textbooks, exercise books, milk, squash, lunch and biscuits. Any books lost have to be replaced by the pupil. **Excursions** are charged at cost.

Fees are subject to revision from time to time but, as far as possible, it is the policy of the School to give parents a minimum of a term's notice of any change made. Fees are payable on the first day of each term. Monthly standing order payments are acceptable by prior arrangement.

A **sibling discount** scheme operates, offering a reduction of 10% in school fees for a second child and a maximum of 12.5% for subsequent children. The reduction applies to the younger child's fees in all cases. If one or more children withdraw from the school, the fees for the remaining pupil with revert to standard.

A full term's notice, in writing, is required before the removal of a pupil, otherwise a term's fee in lieu will

be charged and the deposit is forfeit. In the case of a pupil being requested to leave because of
